Regulations

- 1. These regulations may be cited as the Bandaranaike International Airport, Colombo Regulations 2002.
- 2. The operator may request the operator of the Airport for a special fire cover at the time of refueling the aircraft.
- 3. On a request made under Regulation 2, the Airport Operator shall where he is satisfied that it is necessary and expedient to issue a special fire cover to such Aircraft, a special fire cover shall be issued on payment of the fee specifically in the Schedule hereto.
 - 4. For the purposes of these regulations:—
 - "Airport Operator" shall have the same meaning as in section 21A of the Air Navigation Act;
 - "Operator" means in relation to an Aircraft, a person for the time being having the management of the Aircraft.
