Pursuant to Sec.120 of the Civil Aviation Act No.14 of 2010 which is hereinafter referred to as the CA Act, Director General of Civil Aviation shall have the power to issue, whenever he considers it necessary or appropriate to do so, such Implementing Standards for the purpose of giving effect to any provision in the CA Act, Requirements or Rules made thereunder including the Articles of the Convention on International Civil Aviation specified in the Schedule to the CA Act.

Accordingly, I, being the Director General of Civil Aviation do hereby issue the Implementing Standards on **Certificate of Airworthiness for Export** as mentioned in the Attachment hereto (Ref: Attachment No. IS-8-(3)-Att.), elaborating the requirements to be satisfied for the effective implementation of the International Standards and Recommended Practices on contained in Annex 8, Chapter-3 to the Convention and the Air Navigation Regulations of 1955.

This Implementing Standard shall be applicable to all Aircraft Owners and Aircraft Operators approved by the Director General of Civil Aviation of Sri Lanka and shall come in to force with immediate effect and remain in force unless revoked and it will supersede the requirement in Aviation Safety Notice (ASN) 11.

Attention is also drawn to Sec. 49 and Sec. 103 of the Act, which states inter alia that failure to comply with Implementing Standard is an offence.

## **Implementing Standards**

### **SLCAIS – 061: Certificate of Airworthiness for Export**

#### **GENERAL**

Certificate of Airworthiness for Export is not a flight Authority. It is a document attesting to the Airworthiness Status of an Aeronautical Product.

A Certificate of Airworthiness for Export is issued by the Director-General of Civil Aviation on the request of the Exporter specifying the importing countries special requirements in respect of the airworthiness standard of the aircraft.

The relevant procedures for the issue of C of A for Export are listed below;

1. The exporter on behalf of the importer should formally request the Sri Lanka Director-General of Civil Aviation certificate of Airworthiness for export
2. The exporter should furnish to the Director General Of Civil Aviation the Airworthiness Requirements of the importing country
3. The Exporter should furnish the following documents;
  - a. The applicable Type Certificate with Data Sheet approved and validated in respect of the aircraft.
  - b. List of all major modifications / repairs carried out along with the approvals.
  - c. List of all Airworthiness Directives applicable to the aircraft with compliance certificates and dates.
  - d. Certified history of all hard life components
  - e. Details of any life development programmes
  - f. Back to birth aircraft records
  - g. For large passenger aircraft (MTOM > 5700 kg), approved LOPA.
  - h. List of Operations Derived Equipment fitted and statement of compliance with applicable requirement for such equipment for the Country of Import.
4. The Exporter shall complete the application CAASL/AW/A/006, “Application for Certificate of Airworthiness for Export”. A copy of the application is attached as appendix to this IS.

Subsequent to an adequate review of the above the Director General of Civil Aviation will issue the Certificate of Airworthiness for Export identifying that the aircraft meets the importing country’s requirements or the aircraft meets the requirements of the importing Country and list deviations as applicable.
