## AVIATION SAFETY NOTICE

suspected or actual tyre burst on takeoff.

06. Objective

1) To ensure the safety of the Aircraft after a tyre burst on takeoff.

2) To issue instructions to the Pilot in command for strict compliance as follows.

IT IS MANDATORY THAT PILOT IN COMMAND LAND IN THE DEPARTURE AIRFIELD AS SOON AS PRACTICABLE IN THE EVENT OF A SUSPECTED / ACTUAL TYRE FAILURE OR ON BEING INFORMED BY THE CONTROL TOWER OF A SUSPECTED / ACTUAL TYRE FAILURE.

IN THE EVENT OF SUSPECTED I ACTUAL TYRE FAILURE PILOT IN COMMAND IS TO CONSIDER NOT RAISING THE UNDERCARRIAGE AFTER LIFTOFF AS PER STANDARD PROCEDURES IF PRACTICABLE.

THIS IS DUE TO THE POSSIBILTY OF NOT BEING ABLE TO LOWER THE GEAR SUBSEQUANTLY DUE TO SECONDARY DAMAGE TO THE UNDERCARRIAGE LOWERING MECHANISM.

PILOT IN COMMAND / AIRTRAFFIC CONTROLLER SHALL NOT BE HELD LIABLE IF SUSPECTED FAILURE IS PROVEN TO BE IN THE NEGATIVE.

7. Background

Recently an Airbus A340 suffered a tyre failure on takeoff. The Pilot in command informed the control tower of a suspected tyre burst after takeoff. There were no cockpit indications to conform the event.

On a subsequent inspection aircraft skin parts, tyre pieces and debris of runway centre line light were found on the runway.

The Aircraft returned to the departure airfield after approximately 5 hours and 45 minutes of flight.

## **Aviation Safety Notice**

Inspection of Aircraft has shown that there was substantial damage to a tyre and a part of the area behind the centre gear wheel well was missing.

Secondary damage to the Aircraft due to high speed flight is a matter of serious concern at present.

The purpose of this ASN is to adders this issue.

Presently investigations are under way to ascertain the sequence of events.
