### AVIATION SAFETY NOTICE

01. Subject :- Mandatory carriage of ACAS II and pressure altitude reporting Transponders in Sri Lanka airspace.
02. Compliance :- MANDATORY
03. Status :- New
04. Issue No :- 01
05. Date of Issue :- 2001-09-15
06. Objective :-
- 1) To comply with the amendment to the ICAO Asia / Pacific Regional Supplementary procedures – Doc 7030 / 4 , which adds requirements for mandatory carriage of ACAS II and pressure altitude reporting Transponders from 23 March 2000.
  - 2) To issue instructions to all users of Sri Lanka air space for strict compliance as follows.

**IT IS MANDATORY THAT ALL TURBINE ENGINE AEROPLANES OF A MAXIMUM CERTIFIED MASS IN EXCESS OF 15000 Kg. OR AUTHORISED TO CARRY MORE THAN 30 PASSENGERS SHALL BE EQUIPPED WITH AN AIRBORNE COLLISION AVOIDENCE SYSTEM (ACAS II).**

**THE ACAS II SYSTEM FITTED ON THE AIRCRAFT SHALL**

**(a) BE INCLUDED IN THE TYPE CERTIFICATE ISSUED BY THE CIVIL AVIATION AUTHORITY OF THE COUNTRY OF MANUFACTURE.**

**OR**

**(b) INSTALLED AS A MODIFICATION APPROVED BY A REGULATORY AUTHORITY ACCEPTABLE TO DIRECTOR GENERAL OF CIVIL AVIATION, SRILANKA AND THE MODIFICATION VALIDATED BY THE DIRECTOR GENERAL.**

On 12 January 2000 The President of ICAO Asia and Pacific office , on behalf of the Council, approved the proposal for amendment of the ICAO Asia / Pacific Regional Supplementary Procedures – Doc 7030 / 4 ( Serial number APAC-S 98 / 4- ASIA / PAC – RAC) , which adds requirements for mandatory carriage of ACAS II And Pressure altitude reporting Transponders from 23 March 2000.

Sri Lanka wish to implement this requirement to comply with the decision of the ICAO Asia and Pacific regional office.
