Subject Requirements for Registering of Air Transport Providers (Travel Agents)

Legal Reference This direction issued under the powers vested in the Director General of Civil Aviation in terms of **Section 94, 97 and 121** of the **Civil Aviation Act No. 14 of 2010** and **Air Transport (Passenger) Licensing Regulations of 1993** made in terms of the **Air Navigation (Special Provisions) Act. No. 55 of 1992**.

Description of the Direction

1. All Air Transport Providers (both Group A & Group B) Conducting business of Airline Ticketing in Sri Lanka are hereby directed in terms Civil Aviation Act No 14 of 2010 and paragraph 6 (B) 6 (J) and 9 of Gazette Extraordinary dated 1993.11.19 to:
 - a. Submit a minimum Bank Guarantee to a value of Rs.500,000/= for a Group 'A' Air Transport Providers license.
 - b. Submit a minimum Bank Guarantee to a value of Rs.250,000/= for a Group 'B' Air Transport Providers license.

(The Bank Guarantee amounts may be reviewed as required by the Director General of Civil Aviation from time to time)

2. New Air Transport providers with effect from 1st of July 2015 shall submit an applicable Bank Guarantee with the initial application at the time of applying to obtain an Air Transport Providers License along with a letter of recommendation from an Airline or General Sales Agent operating in Sri Lanka.
3. Existing Air Transport Providers shall submit a Bank Guarantee as applicable along with the renewal application form for the purpose of renewing the current license with effect from 1st of November 2015.
4. Such Bank Guarantee would be utilized on the discretion of the DGCA for the purpose of settling passenger disputes/complaints against the Air Transport Provider after due assessment of such dispute/complaint.
5. This directive will not apply to Air Transport Providers who are functioning as Airlines or General Sales Agents.
