Title: Domestic Aircraft Operator's Security Programme

This Directive is issued pursuant to the provisions made in the Section 87 of the Civil Aviation Act, No 14 of 2010.

Accordingly, domestic aircraft operators including those engaged in General Aviation, Arial work and Flying Schools operating within the territory of Sri Lanka shall establish, implement and maintain a written security programme in accordance with the National Civil Aviation Security Programme formulated by this Authority under the Section 17 of Civil Aviation Act No.14 of 2010, for protection against unlawful interference with Civil Aviation is in place, which has been approved by the Director General of Civil Aviation and the operators shall also fulfill any other requirements as maybe described for that purpose from time to time. However the content of the security programme shall adjusted in meeting with the scope of the operation.

The security programme shall be classified as **RESTRICTED DOCUMENT** and reviewed at least once in 12 months and approval obtained from the Director General for amendments, if any.

This Directive shall come in to force from the 1st day of February 2023 and remain in force unless revised or revoked by the DGCA.

- AVSEC Training –
- Requirement for commercial operators to establish, implement and maintain an Aviation Security Training Programme, which meets the requirements of the National Civil Aviation Security Training Programme (NCASTP).
- Initial and Annual Refresher AVSEC Training: Initial and Annual Refresher training to be conducted for Security Personnel and personnel who carries security as their secondary job functions.
- Initial and Annual Refresher AVSEC Awareness Training:

AVSEC awareness training for Non-Security Personnel, who needs access to the Security Restricted Areas (SRAs) within airport, or similar areas of airports controlled by the military, where civil aircraft operations are conducted.

• Training on Dangerous goods regulations for "No Carry" operators.

Consider persons from Cat 13-17 as per the IATA Dangerous Goods Regulations. i. e;

Cat 13- Operator's and ground handling agent's staff accepting cargo or mail

Cat 14- Operator's and ground handling agent's staff involved in the handling, storage and loading of cargo or mail and baggage

Cat 15- Passenger handling staff

Cat 16- Flight crew members, loadmasters, load planners and flight operations officers/flight dispatchers

Cat 17- Cabin Crew members (other than flight crew members)

• Cat 12- security staff who deal with the screening of passengers and crew and their baggage and cargo or mail
